What is **Project 2025**?

Project 2025 is a plan crafted by Trump's allies and supporters aimed at taking over America's government if Trump wins in 2024. By eliminating checks and balances, they plan to push a far-right agenda without oversight, embedding extremist policies for generations.



PROJECT 2025'S

FOUR PILLARS:

1

A "playbook" designed to dismantle key federal agencies like the Department of Education, Homeland Security, the EPA, and the Department of Justice.

2

A private database of 20,000+ far-right loyalists ready to fill federal appointments, akin to an "extremist LinkedIn."

3

A "Presidential Administration Academy" to train future appointees how to use the government to advance their agenda.

4

A 900+ page "Mandate for Leadership" outlining a complete overhaul of government operations for a new Trump administration.

GOALS

- Take away our reproductive rights
- End programs that address climate change
- End public education
- Persecute LGBTQ+ Americans
- Encourage racial discrimination
- Mass deportation and reduce immigration
- Mainstream Christian Nationalist ideology
- Give unchecked power to the President





Why is this important?

Project 2025 threatens America with book bans, abortion restrictions, and government control over birth control and IVF. It undermines equal rights, free elections, and separation of church and state, aiming to grab power and regress freedoms. Understanding this vision is crucial to mobilizing voters against it in November.



PROJECT 2025'S

ECONOMIC IMPACTS

- **Restrict** rights to start or grow a family when financially able
- **Eliminate** Headstart Preschool
- **Eliminate** the Child Tax Credit
- **Repeal caps** on prescription drug prices
- **Drive up prices** for everyday goods w/ tariffs and national sales tax
- **Increase taxes** on middle class families
- **End** Student Debt Relief
- **Erode healthcare access** by restricting Medicaid and Medicare eligibility
- **Eliminate consumer protections** put in place after housing market collapse

Project 2025 Is Already Being Implemented!

Recent Supreme Court Decisions By Trump Appointed Justices Have Advanced Project 2025

Project 2025 **aims to eliminate the checks and balances our government has in place** so that Trump can successfully implement extremist policies without Congress or federal agencies getting involved. Recent rulings by the court's conservative majority have set the stage for this authoritarian shift, making it easier for Project 2025 extremists to achieve their goals.





CHEVRON U.S.A. VS. NRDC INC.

By overturning their landmark 1984 decision in Chevron v. Natural Resources Defense Council, the Supreme Court has expanded the authority of conservative judges to rewrite rules in favor of corporations and special interest groups. The decision marks another power grab by the conservative Supreme Court majority, aiming to increase corporate and special interest influence over Americans' lives.



TRUMP VS. UNITED STATES

In a 6-3 decision, divided on party lines, the Supreme Court ruled that former Presidents, including Trump, are granted criminal immunity for their official acts during their term, significantly expanding presidential powers and posing a threat to democracy.



SOTOMAYOR, J., dissenting

Never in the history of our Republic has a President had reason to believe that he would be immune from criminal prosecution if he used the trappings of his office to violate the criminal law. Moving forward, however, all former Presidents will be cloaked in such immunity. If the occupant of that office misuses official power for personal gain, the criminal law that the rest of us must abide will not provide a backstop.

With fear for our democracy, I dissent.
