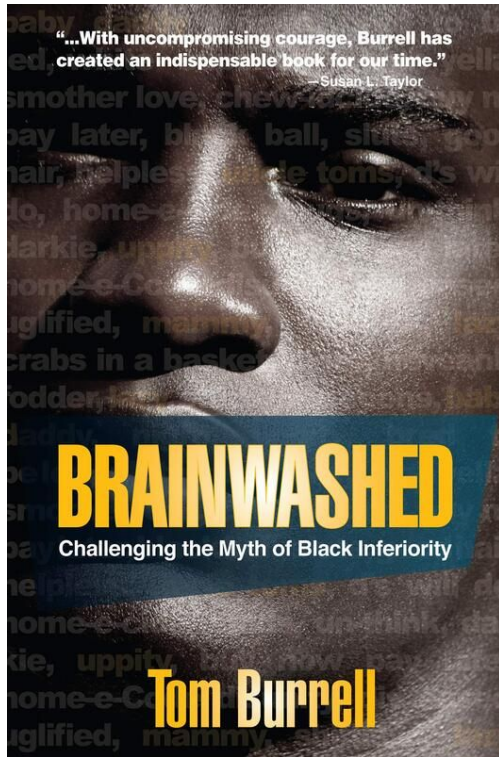

- He writes, **“The early American ruling class used every available tool – religion, law, politics, art, literature, even the nascent field of science – as tool of sales promotion and PR strategy”**

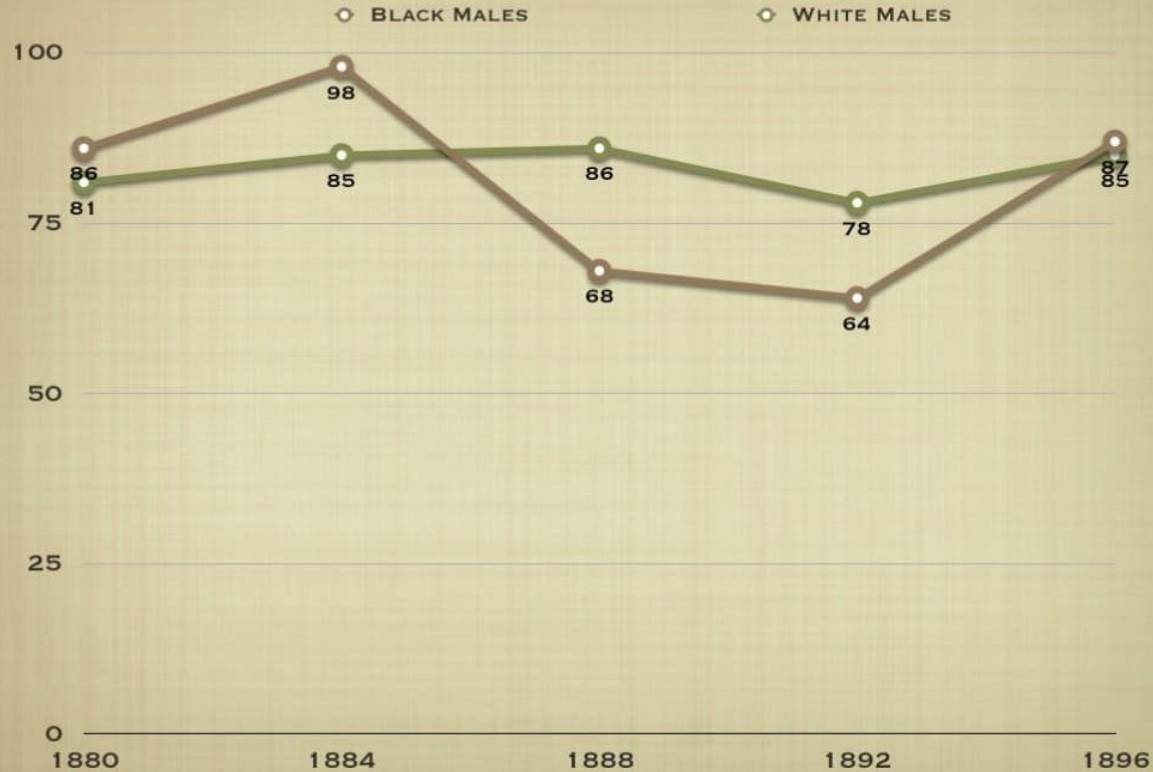

Estimated Percentage Voting for Governor



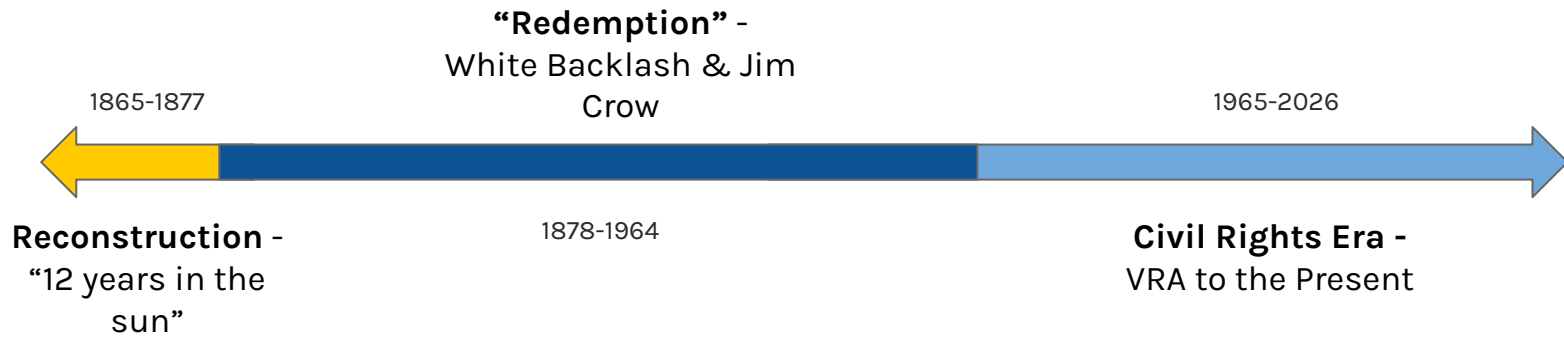
Estimated Percentage Voting for Governor

Weaponized Scrutiny

- ◆ When Black leaders are held to more strictly to supposedly neutral standards (e.g. education, politicians, etc.)
- ◆ Used to create narratives, drain resources, deterrence, and erode public trust
- ◆ *Ex. Dr. Claudine Gay, Former President of Harvard University*

Harvard's Claudine Gay was ousted for 'plagiarism'. How serious was it really?

Gay resigned amid claims of plagiarism, but was it the person being accused rather than the violation itself that brought about her downfall?



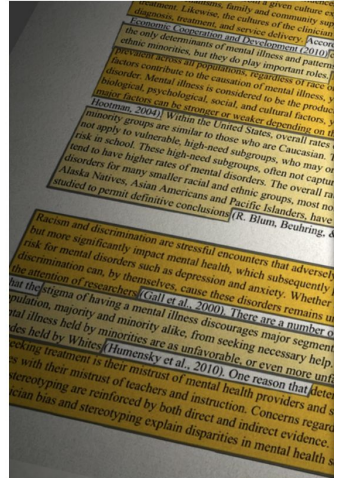

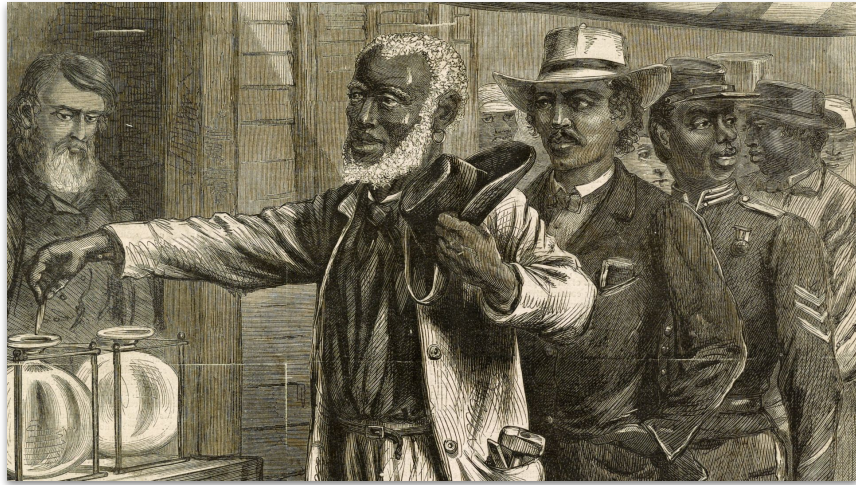

- ◆ Activates emotional response



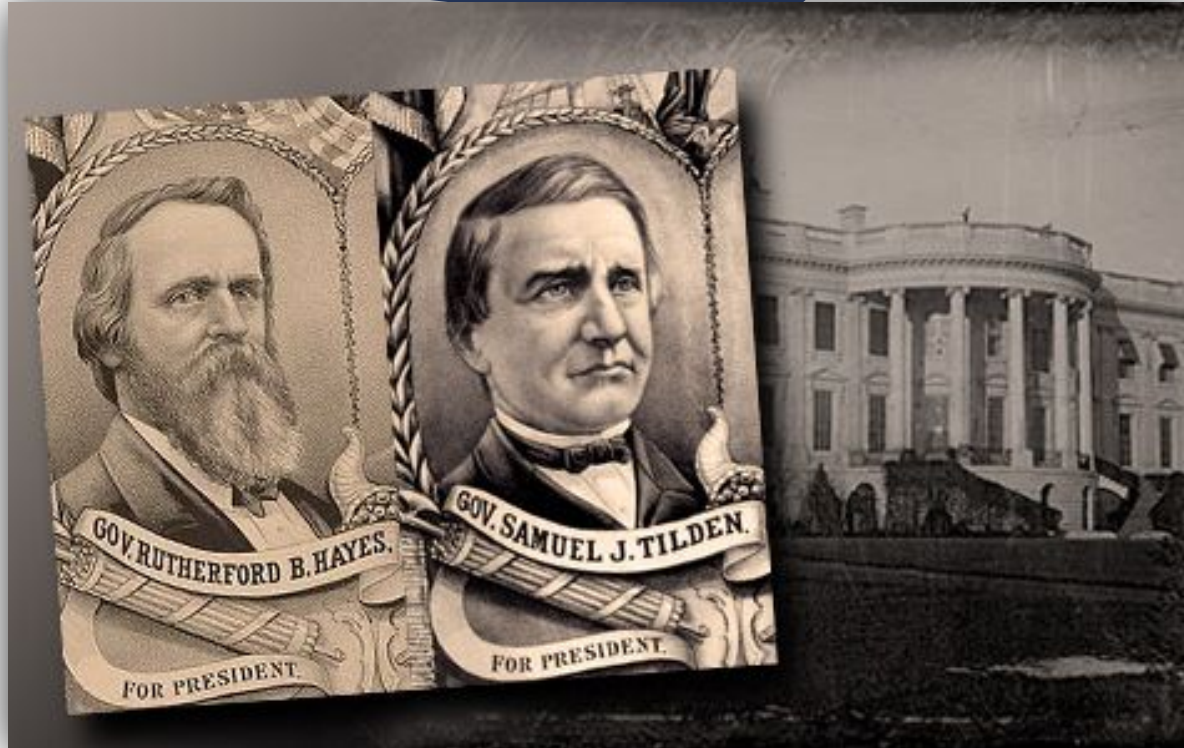

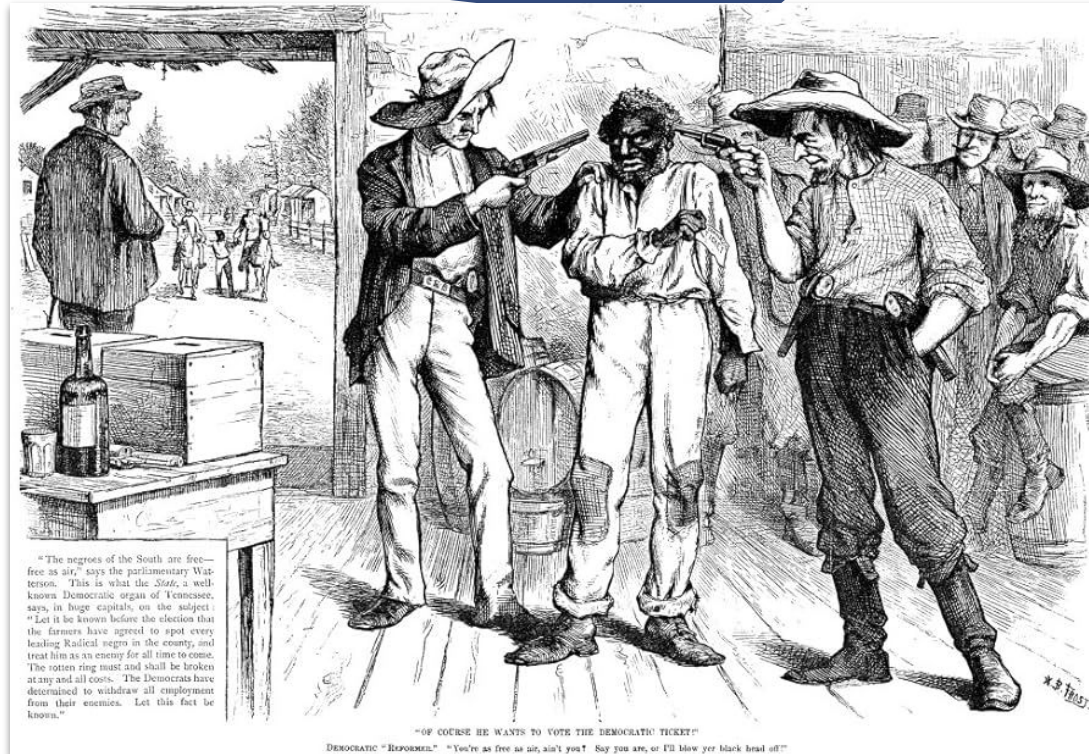

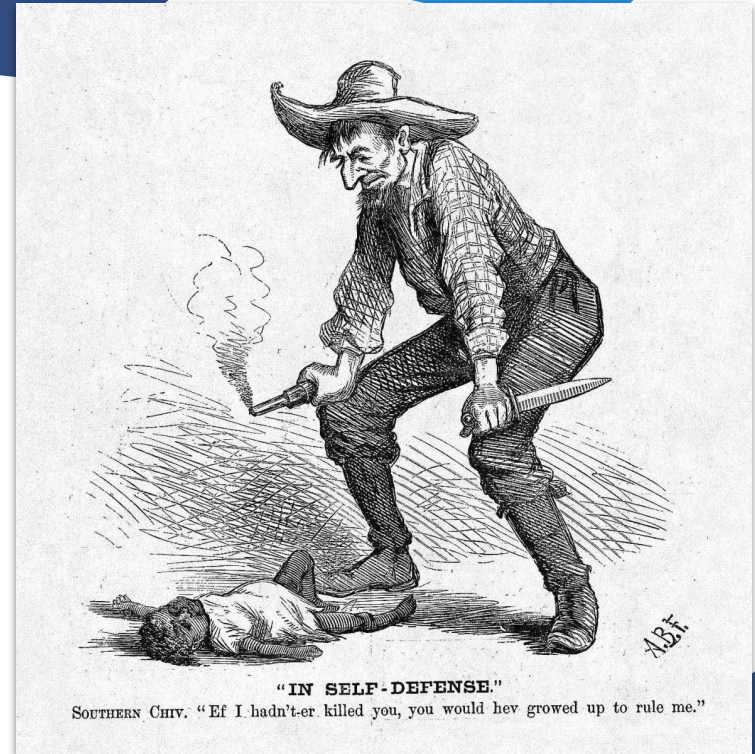

Inside-Out Strategy (Repression & Violence)

- ◆ Poll taxes
- ◆ Literacy tests
- ◆ Grandfather Clauses
- ◆ All-White Primaries
- ◆ Discretionary Registration Processes
- ◆ Timing & Location
- ◆ Economic Reprisals
- ◆ Lynching & Extra-Judicial Violence





Voting Rights Act (VRA) & Modern Tactics

Shelby v. Holder (2013)

- ◆ This case effectively gutted the Voting Rights Act
- ◆ Actions by states no longer required preclearance
- ◆ Made the way for increased Black voter suppression

“Cracking and Packing”

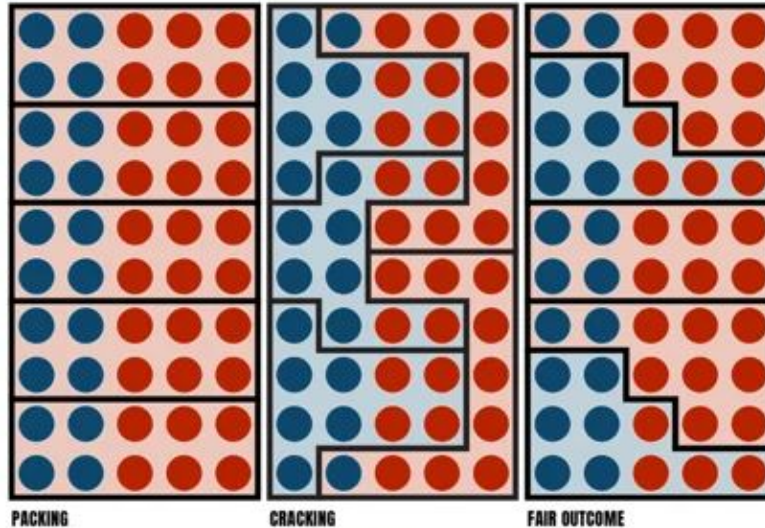
PACKING

The opposing party's voters are pushed into one or a few districts. The majority party surrenders the packed district to the opposition party in order to win other districts.

CRACKING

The opposing party's voters are divided into many different districts, allowing the preferred party to win elections in several districts against a divided opposition.

GERRYMANDERING: How to Steal an Election

Tracking states where officials have adopted new congressional districts or indicated they are open to redrawing them, by party that could benefit.

U.S. House after 2024 elections: ● 220 Republicans ● 215 Democrats

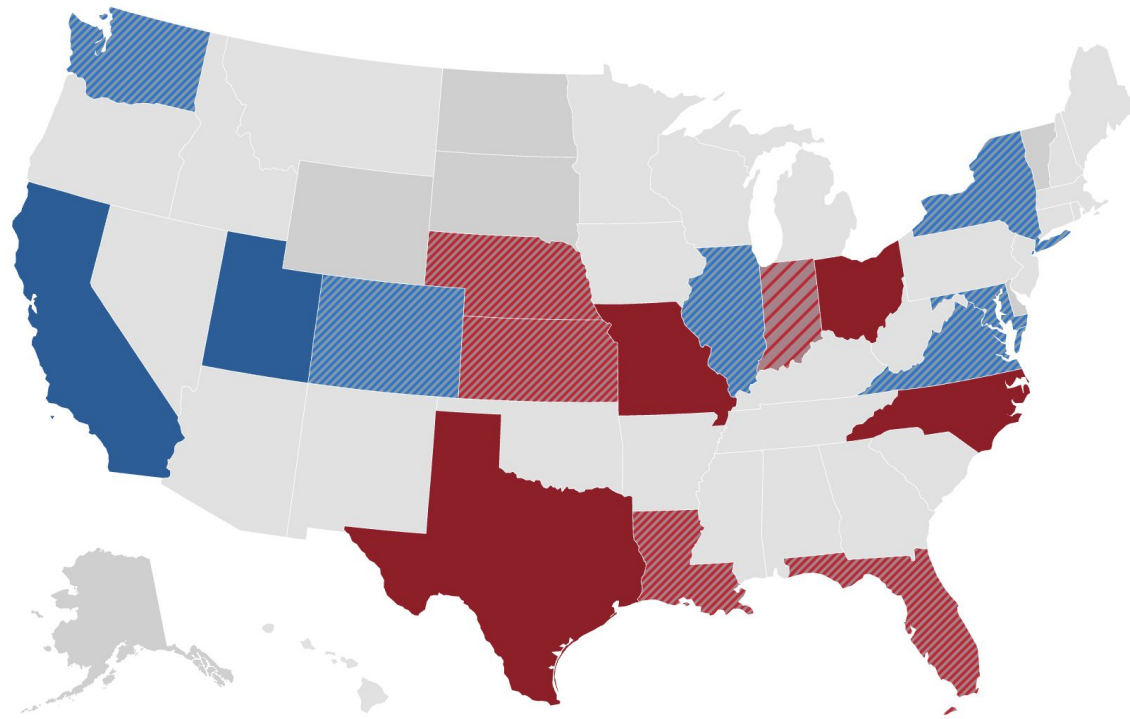

Considering Rejected Adopted new map

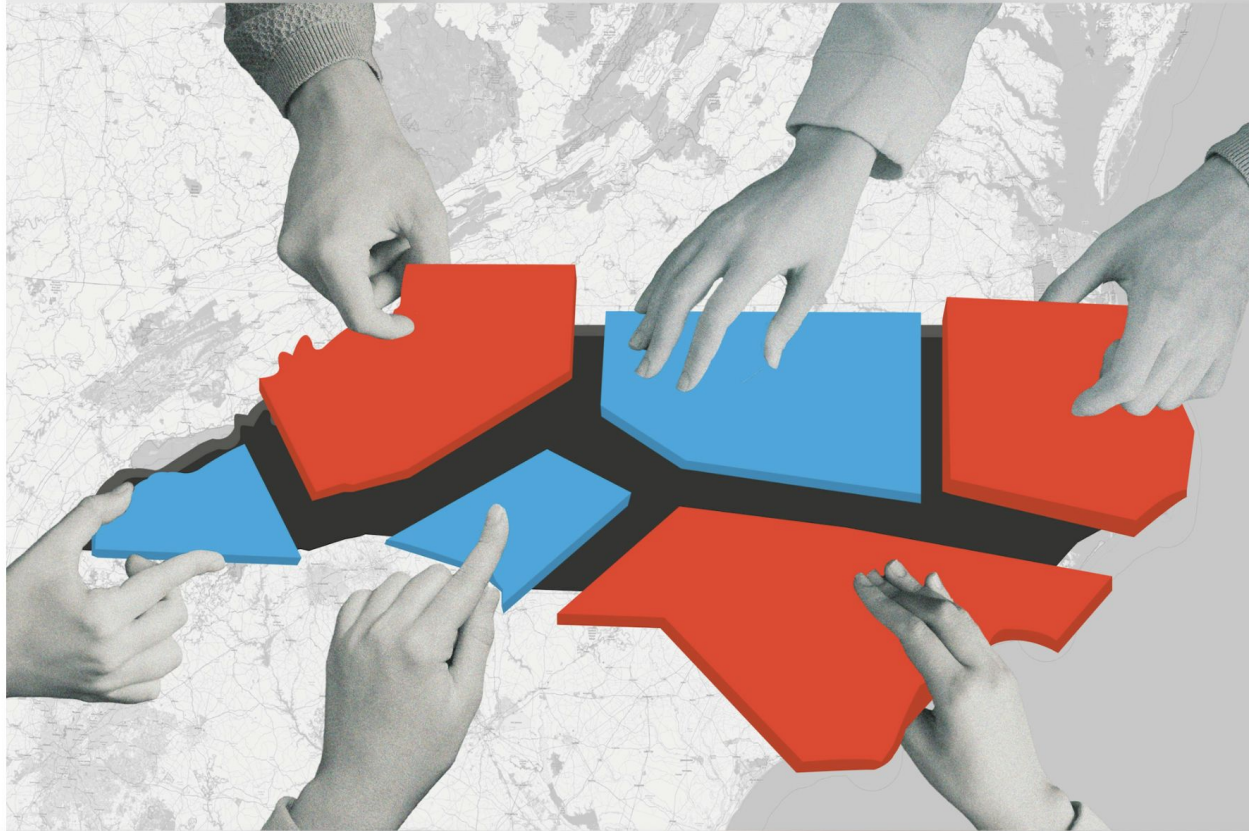
Single-district state No status

The court approved a law to strip the governor's election board powers, risking creating a precedent for partisan power-grabbing.

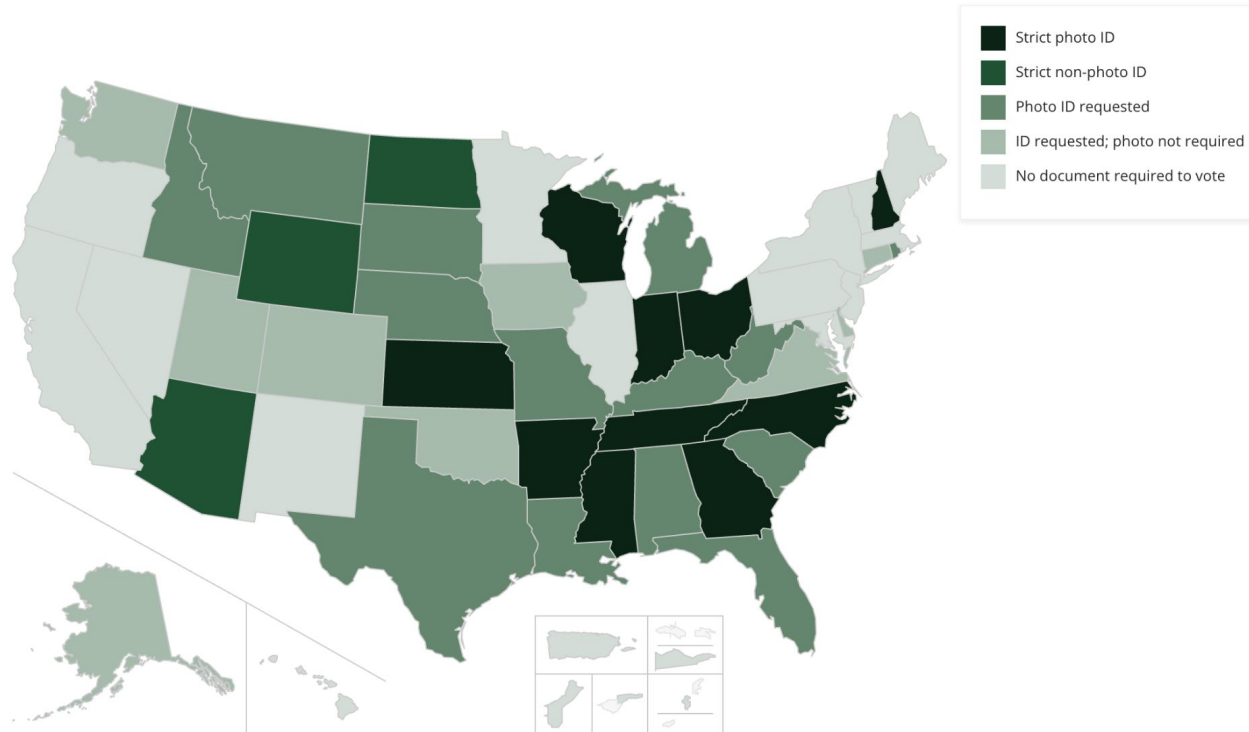
